VISION FOR AGRICULTURE & FOOD FAILS TO ACKNOWLEDGE THE CRITICAL ROLE OF PRIMARY FOOD PROCESSING

The European Commission's Communication, A Vision for Agriculture and Food: Shaping Together an Attractive Farming and Agri-Food Sector for Future Generations, once again neglects the crucial role of primary food processors, including beet sugar manufacturers, in ensuring food security, sustainability, and competitiveness.

Every year primary food processors transform 220 million tonnes of agricultural raw materials (including 100 million tonnes of sugar beets) into essential ingredients for food, feed, and bio-based applications. They are the indispensable link between farmers and downstream distribution, making agricultural raw materials suitable for consumption and storage, and serving as a pillar of the EU's food security. Industries such as beet sugar manufacturing have unique challenges, distinct from farming: we are capital- and energy-intensive, and rely on skilled industrial workers. Despite this, the Commission's Communication dedicates just one vague paragraph to the food industry and makes no mention of primary food processors.

The Vision for Agriculture & Food is not worth of the name: the food industry is treated as an afterthought rather than a mutually-dependent partner of farmers.

CEFS Director General Marie-Christine Ribera said: "The Vision confirms the European Commission's disregard for the unique challenges faced by primary food processors. We call for an Action Plan for the EU's Food & Drink Industry, just as for other industrial sectors, that will recommend concrete policy changes to

support the resilience and competitiveness of our sectors. In the meantime, the EU Primary Food Processors association (PFP) should be granted an observer seat on the new European Board for Agriculture & Food. Currently, FoodDrinkEurope is the only representative of the EU's food and drink sector in the expert group."
